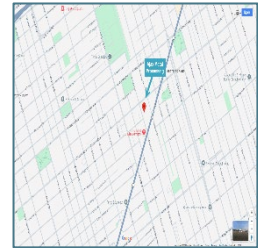

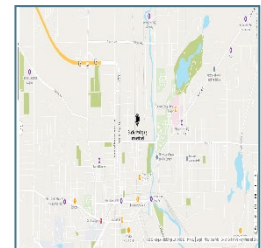

Information on how to submit a petition to the EPA is available at the following website: <https://www.epa.gov/title-v-operating-permits/title-v-petitions>. The time period provided to petition the permit to EPA ends 60 days after EPA's 45-day review period ends (i.e., 105 calendar days after the specified start date of the EPA review).
