VIOLATION NOTICE

On March 12, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Michigan Tile & Marble Co. (facility) located at 9317 Freeland, Detroit, Michigan. The purpose of this inspection was to determine Michigan Tile & Marble Co.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Wayne Co. Installation Permit C-9742.

During the inspection, staff observed the following:

On March 12, 2015, the AQD staff observed operation Marble Cutting and Sanding Equipment while the Dry Filter Mats were not installed. Consequently, the facility was granted a 10-day period to install the dry filters. On March 27, 2015, the AQD staff reinspected the facility and discovered that the said filters were not installed.

This constitutes a violation of Special Condition #17 of Wayne Co. Installation Permit C-9742 and of Act 451, Rule 910, which requires that an air-cleaning device shall be installed, maintained, and operated in a satisfactory manner and in accordance with the administrative rules and existing law.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by April 21, 2015. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been

taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Michigan Tile & Marble Co. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of March 12, 2015.
