### **FACILITY BACKGROUND**

Durr Industries was a manufacturing facility. It appears that the facility has closed the Plymouth, Michigan location and has relocated to Southfield, Michigan. This location is a vacant building with For Sale / For Lease sign near the front. Based on an internet search, it appears that this company has moved to:

#### REQUIRED PPE

I did not enter the facility because the facility was closed, so I did not need any PPE.

#### COMPLAINT/COMPLIANCE HISTORY

No complaints have been received in the last year regarding this facility. No Notice of Violations (NOV) have been issued to this facility in the past five years.

# PROCESS EQUIPMENT AND CONTROLS

It appears that no manufacturing processes are occurring at this location. I was unable to determine if all of the equipment had been removed from this location.

## **INSPECTION NARRATIVE**

I arrived at the facility at 2:30 pm on November 28, 2016. There were multiple flag poles in the front of the building, but there were no flags on any of the poles. There was an unmanned guard shack near the parking lot. There was a sign on the locked door that provided the contact information for this building. The contact person is Kevin Koveck and his number is 586-662-4899. The security arm was up, so I drove around the entire property. There was a For Sale / For Lease sign in the front of the property. There were no vehicles in any of the parking lots on the property. There were no lights on in the building. There were no trucks at any of the loading docks. This facility is not being used for any purpose at this time. The For Sale sign states that this facility has moved to a new North America headquarters.

## APPLICABLE RULES/PERMIT CONDITIONS

This facility has a general permit for a coating line, PTI 344-01, which was issued on

November 28, 2001. This permit was not evaluated because I was unable to enter the facility. It appears that there is no manufacturing occurring at this location. Most likely all equipment has been removed from this location. The equipment may be operating at the new location, located in Southfield, Michigan. Based on the MAERS for 2015, the facility emitted less than 0.2 tons of VOC in the paint booth, which is less than the 10 TPY limit in the general permit.

## MAERS REPORT REVIEW

The MAERS was audited by Mr. Jerry Krawiec on May 11, 2016.

### FINAL COMPLIANCE DETERMINATION

Durr Industries appears to have moved from this Plymouth, Michigan location. The facility does not appear to be operating at the time of the inspection. I was unable to determine whether the equipment has been removed. The facility will remain active in the inspection database until the AQD can confirm that the coating line has been permanently removed from the site.
