VIOLATION NOTICE

On August 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), received a stack test report from Marathon Petroleum Company, LP (Marathon) located at 1300 South Fort Street, Detroit, Michigan. Staff reviewed the results from the June 15, 2016 Crude/Vacuum Heater stack test to determine Marathon's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Permit to Install (PTI) number 63-08E.

Based on a review of the stack test results, the following air pollution violation was observed:

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by September 27, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
