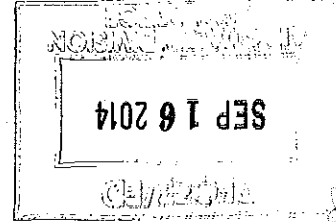

AUG 26, 2014, VN Response

I apologize for not quite understanding the letter you sent me. I only have a sandbox education and I know that is no excuse. After talking to you on the phone, I understand a little bit more what you are looking for.

I started the Clancy Crushed Concrete business over 53 years ago. This at the time was a little farm. There were a few houses in the back of our yard that is 1,350 feet long and 900 feet wide.

We installed a 6 foot solid concrete wall 1 foot on our side of the back property line. We also keep a pile of solid rubble at least 30 ft high to block off some of the noise & etc. We have installed concrete & asphalt drives in back of our main shop to eliminate tracking out on our city street.

We gave the Macomb County a permit drain easement, so they could install a 60" storm pipe to the lake in order to drain this neighborhood from 13 Mile Road to 12 Mile Road from I-94 to Little Mack.

Also, we gave the Macomb County Road Commission 17 feet of our valuable frontage. All of these things were for the good of the people, not only Clancy Crushed Concrete.

Since I started crushing at Clancy Crushed Concrete, I have only received three complaints. #1 was we were making too much dust. Mr. Kenneth L. Green came out with his assistants and measured the air in the back of our yard where the complaint came from. As it turned out, someone was sandblasting concrete walls. It was not from Clancy Crushed Concrete. Mr. Kenneth L. Green was a representative from:

#2 Complained our trucks were making too much noise at night in our yard. We were working for the State of Michigan on I-94 highway night work.

#3 The third complaint was from Mr. Iranna Konanahalli. He said he had a complaint about dust from neighbors.

We were watering our yard 1+ times a day. Since Mr. Konanahalli told us, we increased our watering program to twice a day+. Please keep in mind, too much water causes a problem on the city street.

Violation Notice

I asked Mr. Konanahalli to come back out here and show me what the Rule/Permit Condition consist of. I understand the Process Description Mr. Konanahalli has it all recorded in the letter he sent to me. The comments, I don't understand. Page two of the letter is a repeat of page one with Mr. Konanahalli explaining the crushing operation and the yard conditions.

Except he indicates we have no paving in our yard. Our yard is 90% paved where the trucks are traveling in and out. Our yard equipment and trucks are very well maintained & well kept.

Schedule of Operation – Clancy Crushed Concrete

We usually are open 12 months out of the year.

We normally operate the plant from June 15th through Nov 15th – approximately 5-6 months out of the 12 months of the year. Starting in the month of June, we usually get started about 9:00 am. We shut down 45 min for lunch & start back up between 12:45 pm & 1:00 pm. We shut down for the day at 3:00 pm. We usually spend 45 min to an hour cleaning up around the plant.

From July to end of October we start the plant from 7:45 am – 8:00 am. Plus ½ hour lunch. Shut down at 3:30 pm continue to clean up until finished.

Depending on the weather, we try to operate Monday through Friday. Very very seldom do we operate the plant on Saturday. NEVER on Sunday.

Clancy Crushed Concrete Capacity

Operation of plant averaging 5 to 6 hours per day. 5-day work week. Weather permitting. PLEASE NOTE: This is a completely outdoor operation.

6 hrs per day 5-days per week maybe 175 tons per hour.


$5 \times 6 = 30 \times 175 = 5,250$ tons per week

Approx 20 wks out of year $\times 5,250 = 105,000$ tons per year

These figures are from 2013 which was our best year out of 52 years.

Clancy Crushed Concrete Co. is a little family business. If you want to put us out of business & take away our livelihood – just tell us. We thought we were respecting the United States Constitution and standing up for our heritage.
