AQD staff Chris Robinson was on-site to conduct a scheduled unannounced inspection on Tuesday April 17, 2018. AQD staff arrived at Padnos' Shoreline Recycling Center (Shoreline), formerly known as Fisher Steel and Supply Company, located at 259 Ottawa Street, Muskegon, Michigan, at approximately 12:38pm and met with Kurt Alderink, manager. Proper AQD credentials were presented to Mr. Alderink and CR informed him of AQD's intent to conduct an inspection of the facility to determine compliance status with respect to any applicable air rules and regulations. No odors or visible emissions were observed during this inspection.

Shoreline is owned and operated by Padnos Iron and Metal. Per Mr. Alderink, Shoreline now operates primarily as a scrap metal collection facility. Taking in all kinds of metal scrap, sorting, shearing, and compacting and/or baling it for resale to other metal use facilities. Although this facility receives scrap material from manufacturing facilities, scrap metal collected here primarily comes from individual sources. All shearing and baling equipment is electric.

Although some processing does occur, much of the scrap is sent to the Padnos Holland facility for further processing. This includes scrap too large to be processed at Shoreline. This allows Shoreline to greatly reduce the amount of processing that takes place allowing for a less complicated production yard.

Previously regulated Air Quality processes included an aluminum smelter, a shredder, and an incinerator that burned casings off copper wire. All permits to install have been voided and the equipment has been removed from the site. Shoreline has one (1) on-site portable cutting torch. Mr. Alderink indicated that it is used on a non-production basis primarily for maintenance. Rule 285(2)(j) exempts portable torch cutting equipment that does not cause a nuisance or adversely impact surrounding areas and is used for a non-production basis such as maintenance, repair, and dismantling.

Based on observations made during this inspection, the Padnos Shoreline Recycling Center appears to be in compliance with applicable air rules and regulations.
