Dear Ms. Kelly,

This letter is in response to your letter of violation dated June 15, 2016 regarding Ajax-Plant 7 located at 26400 Sherwood Avenue, Macomb County, in the City of Warren, Michigan. Your letter indicates that on June 8, 2016, you performed an investigation of an odor complaint received by the Michigan Department of Environmental Quality-Air Quality Department (AQD).

Although you were able to confirm odors on June 8, 2016, your letter stated that the frequency of the odors have not been established to warrant a Rule 901 violation. On June 9, 2016, Kathleen Anderson of Axis Environmental Consulting Corporation visited the specific site vicinity along Lawrence Street between Helen Street and Bernice Avenue. She did not detect asphalt odors at the time of her investigation. Although, she did detect odors that were non-asphalt in nature. The plant was operating and the wind direction was consistent with the conditions on June 8, 2016.

Your letter states that you also observed fugitive dust and track out on to Sherwood Avenue. Ajax Plant 7 initiated actions immediately, back on June 8, 2016 to correct this situation, including:

- The frequency of watering the yard, and haul roads was increased on site.
- The frequency of sweeping by an outside contractor, Rolar Property Services, Inc. was increased from once per week to three times per week on Sherwood Avenue and two times a week in the Ajax yard.

Ajax Materials Corporation, Plant 7, has been in compliance with all other MDEQ Air Permit requirements. It should also be noted that there are several other businesses on Sherwood Avenue that contribute to the dust and track out in that vicinity.


