Inspection Summary


It was a partly sunny day and I did not observe any VE's or odors when approaching the area. I arrived at approx. 2:30pm and checked into the office where I met Betty and Curtis Armstrong and introduced myself. I

informed them of the purpose of my visit was to determine compliance with the listed permit for asphalt plant devices and they both responded that the devices had been removed. Betty estimated the removal date was sometime in 1989.

I informed Betty that I would be voiding the associated permits with the location. The letter will be addressed to her. I did not identify any other emission devices on site. Based on my visit, it appears this facility is in compliance with state and federal rules.
