Second deviation is related to failure to read VE's for four week
			at the knock and dump station. Reportedly VE reader thought the requirement was bi-weekly instead of weekly. Retraining was the solution. At this time, this is the first violation of this type and it did not persist for the whole semi annul period. As such, enforcement discretion will be applied. In this case, for the fourth quarter 2020 (October - December 2020), the roads were not treated with a dust suppressant in December due to low temperatures. As the reported weather conditions should have been sufficient to control dust, discretion is being applied in terms of issuing a violation for this deviation.

01/07/2021	ROP Semi 1 Cert	Compliance	Semi annual report from January - June 2020 for Levy Plant 6 was received. 4 deviations were reported. One deviation was for failure to apply dust suppressant in January and February due to precipitation and low temperature. While other similar SIP CO's allow for an exception from application due to precipitation and freezing temperatures, this CO does not. However, reasons given are acceptable. One deviation was for failure to apply dust suppressant because facility operations were shut down in April and June. This is acceptable. However, May is not included. AQD staff needs further information. One deviation was for taking Method 9 readings with non certified readers. This situation occurred due to COVID and the cancellation of smoke school and AQD granted discretion in this situation. One deviation was for one of the finished products (3/4 to 1/2 inch) failure to meet the minimum moisture requirement based on sampling. Company claims this material does not contain fine aggregate and that is has not been processed since this sample result (week of March 22-28). As such, enforcement discretion is being applied in terms of a violation notice. However, AQD will monitor future reports to ensure this is not a recurring issue. Update: email received from the facility verifying that dust suppressant was applied in March and May.
