SECOND VIOLATION NOTICE

On September 16, September 22, and October 15, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted investigations in response to citizen complaints regarding fallout in Detroit and Melvindale. The scope of the investigations included Edw. C. Levy Co. Plant 6 located at 13800 Mellon Street, Detroit, Michigan. The purpose of the investigations was to determine your facility's compliance with the requirements of the Federal Clean Air Act; Article II, Part 55, Air Pollution control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Renewable Operating Permit (ROP) No. MI-ROP-B4243-2009.

On October 28, 2015, the AQD sent the company a Violation Notice citing a violation discovered as a result of the investigations and fallout sample analysis. In the letter, AQD requested your written response by November 18, 2015. A copy of that letter is enclosed for your reference. As of December 8, 2015, AQD has yet to receive Edw. C. Levy's response to the Violation Notice sent on October 28, 2015.

Please be advised that failure to respond in writing and identifying actions the company will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our October 28, 2015 letter by December 29, 2015, which corresponds to 21 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
