**VIOLATION NOTICE**

On February 11, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Spectrum Industries, Inc. located at 700 Wealthy Street SW, Grand Rapids, Michigan. The purpose of this inspection was to determine Spectrum Industries, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; and the conditions of Permit to Install (PTI) numbers 168-98 and 547-95A.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Rack burn-off oven	PTI No. 168-98 Special Condition No. 1	Failure to maintain an average temperature of 1,200°F (plus or minus 50°F)

Records received indicate that for the week of January 26, 2014, Spectrum Industries, Inc. failed to maintain the conveyORIZED rack burn-off oven at the required temperature.


Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by March 13, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a recurrence.

If Spectrum Industries, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
