VIOLATION NOTICE

The Department of Environmental Quality (DEQ), Air Quality Division (AQD), is in receipt of the September 22, 2016, test report submitted by Knauf Insulation, Inc. (Facility), located at 1000 East North Street, Albion, Michigan. Based on a review of the test results, staff of the AQD noted the following:

FG-ML2ALB	40 CFR 52.21(j)/MI-ROP-B7205-2015b, Condition I.1	PM10 emission limit is 4.80 lb/ton glass pulled and tested rate was 5.164 lb/ton glass pulled.
FG-ML2ALB	40 CFR 52.21(j)/MI-ROP-B7205-2015b, Condition I.3	PM10 emission limit is 19.2 pounds/hour and tested rate was 22.723 pounds/hour.
EU-WBWALBFORMING	40 CFR 52.21(j)/MI-ROP-B7205-2015b, Condition I.1	PM10 emission limit is 1.98 lb/ton glass pulled and tested rate was 5.168 lb/ton glass pulled.
EU-WBWALBFORMING	40 CFR 52.21(c), (d) and (j)/MI-ROP-B7205-2015b, Condition I.3	PM10 emission limit is 8.92 pounds/hour and tested rate was 22.229 pounds/hour.


Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by October 24, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
