VIOLATION NOTICE

On October 1, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), received a performance test report for Temperform, LLC located at 25425 Trans-X Road, Novi, Michigan. The test report documented the results of testing conducted on July 23 and July 24, 2024, as required by AQD Consent Order No. 224-04, to determine actual emissions from FGSCRUBBERS1/2.

The test report identified the following violation:

FGSCRUBBERS1/2	Permit to Install (PTI) No. 107-23A, FGSCRUBBERS1/2, Special Condition I.2.	Performance testing documented the exceedance of the permitted volatile organic compound (VOC) emission limit of 0.28 lb/ton of metal melted.

On July 23 and July 24, 2024, performance testing was conducted that documented emissions from FGSCRUBBERS1/2 exceeded the allowed VOC emission limit on a pound per ton of metal melted basis, as specified in PTI No. 107-23A.

The allowed maximum emission rate of VOCs is 0.28 lb/ton of metal melted, while testing documented VOC emissions at 6.06 lb/ton of metal melted.

The cited Special Condition I.2. (FGSCRUBBERS1/2) of PTI number 107-23A is also enforceable under paragraph 9.A. of Consent Order, AQD number 2024-04.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by December 27, 2024, which coincides with 21 calendar days from the date of this letter. The written response should include: the dates the violations occurred; an explanation of the causes and duration of the

violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence. Please submit the written response to EGLE, AQD, Grand Rapids District, at 350 Ottawa Avenue NW, Unit 10, Grand Rapids, Michigan 49503 and submit a copy to Jenine Camilleri, Enforcement Unit Supervisor at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760, as well as to Joyce Zhu, Warren District Supervisor at EGLE, AQD, 27700 Donald Court, Warren, Michigan 48092.

If Temperform, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
