On December 9, 2014 AQD staff conducted an unannounced, self-initiated, level 2 inspection of New Haven Farmers Elevator located at 31071 Division Street in New Haven of Macomb County. The purpose of the inspection was to determine compliance with the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451) and with New Source Performance Standard (NSPS) Subpart DD: Standards of Performance for Grain Elevators.

From 1998 to 1999, New Haven Farmers Elevator had three complaints related to fallout or fugitive dust and one violation notice for a malfunctioning cyclone. New Haven Farmers Elevator repaired the cyclone and have had no complaints or site visits since 1999. The facility is linked with unregistered facility SRN U501415700.

I previously visited the site November 25th, 2014 and noted no odors on surrounding streets. Winds were WSW at 18 mph, the temperature was 32°F, and humidity was 80%. Two construction workers nearby informed me that Holsbeke Construction, Inc. (Holsbeke) now owns the silos associated with the New Haven Farmers Elevator.

On December 9, 2014, Mr. Christopher Holsbeke, Project Manager, accompanied me on the site. He explained that Holsbeke acquired the New Havens Farmer Elevator in March of 2014. Currently Holsbeke uses a separate building at the same address for equipment storage. Holsbeke has not done anything with the grain elevator, but it plans to paint the elevator at a minimum. The City of New Haven asked Holsbeke to keep the silos as a town landmark. Holsbeke plans to renovate the silos for preservation. I looked inside the silos and saw that they are not operational. Holsbeke has no plans to use the elevator or silos for grain storage.

Because the grain elevator is no longer in use, the facility is not subject to NSPS Subpart DD nor is it subject to the provisions of R201.




Image 2(Building): Red building adjacent to elevator. Holsbeke storing construction equipment here.
