VIOLATION NOTICE

On June 25, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Warwick Cleaners, 2121 Warwick Street, Saginaw, Michigan. The purpose of this inspection was to determine Warwick Cleaners' compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this dry cleaner is subject to the Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents. According to our investigation, Warwick Cleaners owns the facility and J&M Service & Equipment, Inc. installed the equipment at the facility with another contractor. The Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents holds both the owner and the installer equally liable for violations.

During the inspection, staff observed the following:

Also, we recommend that you do not dump any wastewater from the dry cleaning or wastewater treatment unit machine down the drain.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by July 24, 2019 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Warwick Cleaners, and J&M Service & Equipment, Inc. believe the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
