SECOND VIOLATION NOTICE

On May 17, 2022, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection of Jenison Cleaners, Inc. located at 316 Baldwin Street, Jenison, Ottawa County. The purpose of this inspection was to determine Jenison Cleaners, Inc. compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended; and the Air Pollution Control Rules.

Specifically, this dry cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (40 CFR), Part 63, National Emission Standards for Hazardous Air Pollutants for Source Categories, Subpart M and the Public Health Code, Act 368 of 1978, as amended; Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

On May 19, 2022, the AQD sent the company a Violation Notice citing violations discovered as a result of the inspection and requested your written response by June 9, 2022. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying the actions the company will take or has taken to resolve the cited violations may result in escalated enforcement actions by the AQD. Please provide the information requested in our May 19, 2022 letter by August 17, 2022, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit EGLE's ability to initiate any other enforcement action under state or federal law as appropriate.
