12/11/17- Chris Hare and I (Matt Karl) arrived on site at the Caro Regional Mental Health Center located at 2000 Chambers Road, Caro, MI 48723. The facility has previously held permits with the DEQ AQD for boilers used to provide heat and power the complex's buildings and an incinerator for on-site waste disposal. The facility was open and operating at the time of our inspection. Chris and I checked in at the Administrative Building's (Fig. 1, Building 51) front desk and exchanged contact information with Brian Hecht (Physical Plant Supervisor).

Chris and I then proceeded with our inspection, driving over to the first of the facility's power plants (Fig 1., Building 63). Outside of Building 63 we noted the presence of a Cummins generator unit. Inside Building 63 we met with Pat Donnelly (Power Plant Maintenance) who gave us a tour of Building 63 and looked up the operating specifications of the Cummins generator unit, which was installed 03/2017. The Cummins generator is a 750 kW, natural gas (NG) powered model and undergoes load testing once a month. There is currently one Johnston Boiler Company NG unit (9695-01) in operation within Building 63 (Fig. 2). There is also a Wickes NG boiler unit (9968) which was currently not in operation at the time of our inspection, but which could be brought online as backup for the other boiler(s).

We then proceeded to the second of the facility's power plants (Fig 1., Building 118). There are currently two Johnston Boiler Company units (9334-01 and 10870-01) in operation within building 118. Boiler unit 9334-01 "Boiler B" (Fig. 3) runs solely on natural gas while Boiler unit 10870-01 "Boiler A" (Fig. 4) is currently running on Fuel Oil #2 (diesel).

Summary: Based on the 12/11/17 inspection of the Caro Regional Mental Health Center's power plants, all of the emission units appear to be exempt from permitting requirements (see table above). Therefore, at the time of the inspection the facility appears to be in compliance.




Image 1(Site Map) : Caro Regional Mental Health Center Site Map

Image 3(Boiler Plate 9334-01) : Power Plant Building 118, Dickerson Drive, Indian Fields Township, MI 48723






Image 4(BoilerPlate 10870-01): Power Plant Building 118, Dickerson Drive, Indian Fields Township, MI 48723
