The Detroit database indicates that there is a business by the name of Triangle East Inc. operating at 18555 East Warren Avenue, MI 48236.

The records on file show that a permit identified with the number 8354 was issued by the City of Detroit to Triangle East Inc. for the installation of an incinerator at 18555 E. Warren Avenue, MI 48236. The specific date of permit issuance is unknown, but according to the design plans, the City of Detroit Department of Building and Safety Engineering examined and approved the construction plans on February 2, 1957 and the Bureau of Smoke Inspection and Abatement examined and approved the construction plans on February 26, 1957.

There are not additional records in AQD files describing other equipment and/or process operations at the cited location.

On 9/14/2018 AQD I arrived at the cited location to conduct an inspection of the facility. I did not find any business with a name "Triangle East Inc."; but instead, there was a CVS Pharmacy located at the NE corner of E. Warren Avenue and Anatole Street, with address 18585 E. Warren Ave. Walking southwest on E. Warren Ave. and across Anatole St. there was small Real State, Broker (Dan J. Green) building with address, 18545 E. Warren Avenue. Therefore, it seems like the parcel occupied by the CVS parking lot was probably the area where the old business "Triangle East Inc.", was standing.

Google Earth satellite imagery of the area suggest that sometime between 4/29/2002 and 10/29/2004 Triangle East Inc. was demolished. The specific dates for equipment removal, building demolition and construction of the new business is unknown. The attached images show the transition pictures from Google Earth for 2002 and 2004 and the 2018 status of the geographic area where the former facility seemed to have been located.

Permit No. 8354 will be voided as the building that formerly housed the permitted equipment have been demolished. Permits that are identified after the completion of this report will be automatically voided. A void letter will not be issued because the address **GRE Hart Street**, Detroit, MI 48214 is not active.

The source is in compliance for the reason that no air emissions activity remains at this address. The source status will be entered as permanently closed.
