BACKGROUND

According to AQD records, the building located at 12202 Newburgh, Livonia, MI 48150 was formerly occupied by a company called Corporate Upholstery, Inc. The company was an office furniture coating business which operated a painting spray booth and a bake oven. The records on file show a Wayne County installation permit number C-9571 with confirmation agreement signed by the president of the company, Mr. Larry Henry, and dated 2/20/92.

During the preparation for this inspection I conducted an entity search using the online services of the Department of Licensing and Regulatory Affairs (LARA) for the Corporate Division. In a search by name I found that "Corporate Upholstery, Inc." is no longer in business. The records show that the company ID Num. 270442 was dissolved on 2/ 26/1998 (see attachment). However, part of our responsibility as field inspectors is to verify if the company is operating under another business name in the same location, or if there is another type of business occupying the location which could potentially be subject to Air Pollution Regulations.

A search in Google Earth showed a company identified as "Applied Process" located at 12202 Newburgh, Livonia, MI 48150. According to their website this company is a Metal Heat Treating facility. I looked into our MACES database to verify if a company with that name had been registered in our system. I found out that Applied Process, Inc., SRN M4313, located in Livonia was listed under another address (12238 Newburgh Rd.). In fact, this Metal Heat Treating facility has been permitted by DEQ/AQD and the assigned inspector from our Detroit Field Office is Jill Zimmerman.

INSPECTION NARRATIVE

On March 24, 2015 I conducted a site visit to clarify the discrepancies that have been cited above. At about 10:00 AM I arrived at the building located at 12202 Newburgh, Livonia, MI 48150. Upon my arrival at the site I noticed that the name on the front of the building read: "Applied Process". I entered the building, showed my State employee I.D. and explained the reason of my visit. At the reception desk I was received by Ms. Holly Capehart, Staff Accountant for Applied Process Technical Division. She indicated that she was aware of the previous company (Corporate Upholstery, Inc.) operating in their building. She further stated that Applied Process had leased the building for some period of time, and later on they bought the building to accommodate the Technology Division Headquarters. I asked if there was any other operations in that building other than the headquarter offices. She said that there are only offices in that building and all the equipment for the Metal Heat Treating

Process Plant was located at the contiguous building at 12238 Newburg Rd, Livonia MI 48150. I expressed thanks to Ms. Capehart and left the site at about 10:15 am

CONCLUSIONS

Based on the information in our files and as a result of the site inspection, it is concluded that the office furniture coating business known as "Corporate Upholstery, Inc." (SRN M4126) ceased their operations. Therefore, the Wayne County permit number C-9571 issued to the facility on 2/28/92 for the installation and operations of the coating equipment will be voided, and the file will be closed.
