

VIOLATION NOTICE

On March 17, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), received the Annual Certification of Compliance, Semiannual Compliance Report and Compliance Assurance Monitoring (CAM) data for Zeeland Farm Services, Inc. located at 2525 84th Avenue, Zeeland, Michigan, as required by Renewable Operating Permit (ROP) number MI-ROP-M4204-2012a. A review of the submittal was conducted to determine Zeeland Farm Services, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the administrative rules.

During the review, staff observed the following:

FGEXTRACTION	MI-ROP-M4204-2012a, Special Condition VI.2	Failure to collect temperature of meal at required interval.
FGEXTRACTION	MI-ROP-M4204-2012a, Special Condition VI.4	Failure to record percent LEL at required interval.

The permit violations identified above have been ongoing as reported to the AQD. The proposed corrective action identified by Zeeland Farm Services, Inc. which has consisted of staff re-training, is no longer considered sufficient. Please submit an updated CAM plan with approvable monitoring to meet performance criteria.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by April 24, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Zeeland Farm Services, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
