**Summary of Facility Visit and Compliance Status:**

Naturalicious, located at 11871 Belden Court, Livonia, Michigan, was identified as a targeted inspection for 2019 due to the close proximity to ambient air trichloroethylene (TCE) concentrations that were detected as part of the Ford Beacon Project indoor air monitoring at addresses along Belden Court. For information regarding the ambient air sampling conducted as part of the Ford Livonia Transmission Plant remedial investigation, please see SRN A8645, MACES report CA\_A864547612. The Detroit District files, the Detroit Data Base, and Permit Cards indicates one active permit (Wayne County Installation Permit C-8198, Glue Spray Booth) for the address. However, based on Wayne County inspection report dated May 30, 1996, Permit C-8198 was voided at that time. AQD databases will be updated to reflect C-8198 as voided on May 30, 1996.

On July 31, 2019 Mr. Todd Zynda and Ms. Rebecca Loftus arrived at 1:14 PM at 11871 Belden Court. According to facility personnel, Naturalicious has been operating at 11871 Belden Court for approximately one month. The facility consists of office space and a warehouse area. During the inspection the office space and warehouse were observed. The warehouse is used to store soaps and lotions. The warehouse area ia also used to mix soaps and lotions (by hand).

The facility does not operate any of the following equipment: boilers, cold cleaners, or emergency generators. Wayne County Installation Permit C-8198 was voided on May 30, 1996 per Wayne County inspection report of the same date. The glue spray booth has been removed from the facility.

Operations at the facility do not appear to be subject to air quality rules or regulations. The source is considered to be in compliance for the reason that no air emissions activity occurs at this address.
