AQD's Detroit Database lists a business by the name of H.B.L. Enterprises, Inc. in operation at 89 East Robinwood, Detroit, Michigan, 48203. The records on file indicate that the H.B.L. Enterprises was issued Wayne County Installation Permit C-10417 for the installation of a heat cleaning oven with integral afterburner.

According to the State of Michigan's Business Entity Search (compiled by the Department of Licensing and Regulatory Affairs [LARA]), H.B.L. Enterprises underwent automatic dissolution on July 15, 2001.

On January 14, 2014 the Michigan Department of Environmental Quality (MDEQ) Air Quality Division (AQD) inspector, Mr. Todd Zynda conducted a level 2 unannounced inspection of 89 East Robinwood, Detroit, Michigan. During the inspection, Mr. Gary Flockhart, Owner of Specialty Glass, provided information and a tour of facility operations relating to air quality permits. The inspection was conducted to determine the facility's compliance with the Natural Resources and Environmental Protection Act (NREPA), Act 451, Part 55, and Wayne County Installation Permit C-10417.

At 1:40 PM, Mr. Zynda entered the facility, stated the purpose for the inspection, and was greeted by Mr. Flockhart. According to Mr. Flockhart, Specialty Glass has been operating at 89 East Robinwood for the last six years (since 2008). Specialty Glass cuts and combines thermopane glass for a variety of customers. In addition, Specialty Glass also sells mirrors, tempered glass, and laminated glass. Glass is not made it at the facility. All glass is brought in in large sheets and cut and combined per customer specifications. The heat cleaning oven is no longer present at the facility. Mr. Flockhart was not aware of the heat cleaning oven being present at the location. During the inspection, the glass manufacturing area (cutting and combining) was observed, along with a storage area used for housing company vehicles. Small natural gas heaters were observed during the inspection. The natural gas heaters are exempt from permit to install requirements under the following Rule.

R 336.1282(b)(i): Fuel burning equipment which is used for space heating.... And burns natural gas and the equipment has a rated heat input capacity of not more than 50,000,000 Btu per hour.

Wayne County Installation Permit C-10417 will be voided. A void letter will not be issued as H.B.L Enterprises is no longer an active company and is not operating at 89 East Robinwood. Specialty Glass appears to be in compliance with federal and state air quality regulations.
