Summary of Facility Visit and Compliance Status:

AQD's Detroit Database lists a business by the name of Corum Cabinet Works (Corum) in operation at 12568 Inkster Road, Redford Charter Township, Michigan, 48239. The records on file indicate that Corum was issued Wayne County Installation Permit C-9876 for an adhesive spray table with hooded exhaust system.

On May 27, 2015 Mr. Todd Zynda arrived at 2:00 PM in the area of 12568 Inkster Road. The address 12568 Inkster is located in a small industrial park named Redford Industrial Commons. The location was secured and did not appear to be an active business. There were no signs at the address indicating a business name. Employees at an adjacent business stated that they did not know if 12568 Inkster was occupied. The contact information for the owner of Redford Industrial Commons, who owns address 12568 Inkster Road was obtained. AQD left the area at approximately 2:15 PM.

According to the State of Michigan's Business Entity Search (compiled by the Department of Licensing and Regulatory Affairs), Corum has an automatic dissolution date of July 15, 1999.

On May 29, 2015, a phone call was held with Mr. Mike Lucht, owner of Redford Industrial Commons. According to Mr. Lucht, Corum has not operated at 12568 Inkster since 2004 or earlier. Mr. Lucht stated that the address is currently used as warehousing space and there is no manufacturing or process equipment located on site. It was discussed that permit C-9876 would be voided.

Wayne County Installation Permit C-9876 will be voided. A void letter will be issued to Mr. Mike Lucht, owner of Redford Industrial Commons at 5202 Enterprise Boulevard, Toledo, Ohio, 43612. The source is considered to be in compliance for the reason that no air emissions activity remains at this address. At this time, no further investigations regarding air quality permits is necessary.
