INSPECTION NARRATIVE

I arrived at the 10023 W. Fort Street address on December 7, 2020 at 1130 hours. Purpose of the visit was to conduct a scheduled compliance inspection with respect to the Wayne County permit conditions issued to the facility. I approached the address from Fort Street Eastbound and crossed the Rouge River Draw Bridge. The 10023 W. Fort Street was located on the Southside of Fort Street. The building carried the Street address. However, the business sign had been removed. The entrance into the building was barred with iron bars across the bay door, and the driveway barricaded. There was no sign of activity at the site.

DETERMINATION

The inspection of Rayco Plating Inc. revealed the facility had closed its business at the location. Attempts made to communicate with the company manager were not successful. Staff determined the facility no longer operates business at the location. All Wayne County and associated permits are regarded void. The facility is determined to be in compliance with Michigan Air Quality rules with respect to pollutant emissions.
