FACILITY BACKGROUND

Sora Limestone Quarry was located at 20837 N. Huron River Drive in Brownstown, Michigan. The facility was owned by Great Lakes Aggregates, LLC. The facility conducted quarry operations, crushing, screening, and processing of limestone. The facility has dismantled all crushing equipment and removed all of the equipment. This allowed the quarry to fill with water, which effectively closed the quarry.

COMPLAINT/COMPLIANCE HISTORY

No complaints have been received during the past two years regarding this facility.

OUTSTANDING VNs

All issued Violation Notices (VN) have been resolved.

PROCESS EQUIPMENT AND CONTROLS

The facility was permitted under Wayne County permits C-7580, C-10294, C-10520 through 10525, and C-10737 through 10739 for a limestone crushing plant that included a grizzly feeder, jaw crusher, 2 vertical shaft impactors, 2 cone crushers, and 3 wet screens. Permit 16-09 for diesel generators had been voided on 03/20/2012.

INSPECTION NARRATIVE

This facility is no longer operating. All of the equipment has been removed.

APPLICABLE RULES/PERMIT CONDITIONS

The crushing equipment is permitted under Wayne County permits C-7580, C-10294, C-10520 through 10525, and C-10737 through 10739. The diesel generators are permitted under Sate of Michigan permit 16-09. All of the equipment has been removed from the site. Therefore all of the permits will be voided.

MAERS REPORT REVIEW

MAERS was last received on 03/20/2012. There were no emissions during 2011 because operations at the facility had stopped.

FINAL COMPLIANCE DETERMINATION

Sora Limestone appears to no longer be operating at this location, as all of the equipment has been removed from this location. All Wayne County permits have been voided.
