SECOND VIOLATION NOTICE

On April 2, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection of the industrial property located at 3000 Miller Road in Dearborn. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On April 16, 2024, the AQD sent a Violation Notice (VN) citing violations discovered as a result of the inspection and requested a written response by May 10, 2024. A copy of the violation notice has been enclosed for your reference. The AQD has reviewed your submitted response to the VN. However, the response to the violation is inadequate as the response does not provide factual information that explains why Commercial Industrial Services, Inc. believes the observations or statements are inaccurate and do not constitute violations of the applicable legal requirements cited.

Please be advised that failure to respond in writing and identifying actions taken to resolve the cited violation may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated April 16, 2024, by June 21, 2024, which corresponds to 14 days from the date of this letter.

The written response must be submitted to Jeremy Howe, Technical Programs Unit at EGLE, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760, and must include a copy to Jason Wolf, Enforcement Unit at the same address. Or the response may be scanned and sent to HoweJ1@Michigan.gov and WolfJ2@Michigan.gov.

Be further advised that issuance of this VN does not preclude or limit EGLE's ability to initiate any other enforcement action under state or federal law as appropriate.
