## VIOLATION NOTICE

On October 26, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) issued Permit to Install (PTI) 547-87N to Albrecht Sand and Gravel located at 3051 Cat Lake Road, Caro, Michigan. The purpose of the permit modification was to change Albrecht Sand and Gravel from a portable asphalt plant to a stationary asphalt plant. The facility is required to comply with all conditions in Permit to Install (PTI) number 547-87N; the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the Air Pollution Control Rules

Since the issuance of PTI 547-87N, staff observed the following:

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by January 30, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
