Dear Mr. Durham:

This letter is written in response to your correspondence dated July 11, 2018 regarding uncontrolled fugitive dust at the intersection of Chubb Road and Six Mile Road. As requested, we are sharing corrective actions that have been and will be taken to address this situation.

On July 22, 2018, the Washtenaw County Road Commission, on behalf of Salem Township, contracted for the paving of Chubb Road approximately 800 feet south of Six Mile Road, including the commercial drive approach of Calo Trucking, to Six Mile Road. This hot-mix asphalt surface should minimize the amount of tracking onto Chubb and Six Mile Roads and the associated dust from the tracked material.

In addition, the Road Commission is partnering with Salem Township on the reconstruction and paving of Chubb Road from Five Mile Road to Six Mile Road as well as Five Mile Road from Chubb Road to Napier Road. This additional pavement should be a long-term solution to any other dust issues in the area.
