On November 15, 2023, staff Chris Robinson and Dillon King from Michigan's Department of Environment, Great Lakes, and Energy (EGLE) Air Quality Division (AQD) conducted an inspection at West Michigan Molding (SRN N2146) located at 1425 Aerial View Drive in Grand Haven Michigan. The purpose of this inspection was to determine this facility's compliance with applicable state and federal air quality rules and regulations including Permit to Install No. 213-00E.

AQD staff met with West Michigan Molding's Chief Financial Officer, Steve Berkenpas who informed AQD staff that West Michigan Molding ceased normal operations in July 2023 with a complete shutdown at the end of September 2023. Both the former owner, Dale, and engineer, Kevin, were onsite. Per Steve, the building and remaining equipment were now owned by the liquidation company and all equipment has been disconnected and prepped for sale/shipment. Kevin provided a walk through, and all spray booths remain onsite, but the power has been disconnected and the stacks have been removed. Also, some of the plastic injection machines remain but power has been disconnected.

CR discussed voiding PTI 213-00E which both Dale and Steve requested to void. A void request was submitted by CR on 11/27/2023. The facility also had questions regarding the equipment inventory letter received by AQD. They were unsure on how to complete it since the person responsible was no longer available. CR spoke with Dennis McGeen and was informed to notify Amie Hartman once the request was made, and they will take it from there.

The facility submitted their 2021 MAERS on time and complete. Reported emissison are consistent with previous year submittals.

Since the facility is closed and most of the equipment has been removed, CR did not review any records and is considering this facility in compliance with PTI 213-00E. Also, Maces operating status for West Michigan Molding has been changed to "Permanently Closed".
