## VIOLATION NOTICE

On July 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Barron Industries, Inc. located at 215 Plexus Drive, Oxford, Michigan. The purpose of this inspection was to determine the facility's compliance with the requirements of the federal Clean Air Act, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451), the administrative rules, the conditions of Permit to Install (PTI) numbers 136-90A and 994-90, and the requirements of 40 CFR Part 63 Subpart ZZZZZ (Iron and Steel Foundry Area Source NESHAP).

During the inspection, staff observed the following:

The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Barron Industries believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
