Response to Violation Notice, April 11, 2019

Arbor Hills Energy LLC ("AHE") - MI-ROP-N2688-2011

Dear Mr. Kovalchick:

I am writing in response to the above-referenced NOV, which in turn was based on inspections conducted by the Michigan Department of Environmental Quality ("MDEQ") Air Quality Division ("AQD").

We understand that MDEQ has had discussions with Advanced Disposal Services, Arbor Hills Landfill Inc. ("ADS") related to the Elevated Temperature Landfill ("ETLF") event cited in the NOV. As documented in the attached letter dated March 28, 2019, ADS explained to MDEQ that the elevated temperatures were related to the non-methanogenic degradation process of a special waste stream accepted at the landfill. ADS provided MDEQ with proposed corrective action and requested Higher Operating Variances ("HOVs") based on a compilation of data that demonstrated the lack of CO (typically linked to subsurface oxidation events). We understand further, pursuant to a letter from MDEQ to ADS dated April 11, 2019, that MDEQ did not approve the HOVs.

Fortistar performs operation and maintenance activities at the wellfield as directed by ADS and will implement, in close coordination with ADS, any practice approved by MDEQ. However, we reiterate that a higher operation temperature is required for these wells as that would optimize gas collection and release the temperature of chemical reaction occurring within the waste mass.
