VIOLATION NOTICE

On October 22, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Sheridan Publishing Grand Rapids, Inc. located at 5100 33rd Street SE, Grand Rapids, Michigan. The purpose of this inspection was to determine Sheridan Publishing Grand Rapids, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 114-13A.

During the inspection, staff observed the following:

Three lithographic printing presses	PTI No. 114-13A, FG-OffsetLitho, Special Conditions VI.1, VI.2, VI.3, and VI.5	Failure to maintain emissions records for 2024.
All process equipment	PTI No. 114-13A, FGFACILITY, Special Conditions VI.1 and VI.2	Failure to maintain emissions records for 2024.

During this inspection, Sheridan Publishing Grand Rapids, Inc. was unable to produce emission records.

This is a violation of the recordkeeping limitations specified in FG-OffsetLitho, Special Conditions VI.1, VI.2, VI.3 and VI.5 and FGFACILITY, Special Conditions VI.1 and VI.2 of PTI number 114-13A.

The conditions of PTI number 114-13A require that the permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor by the last day of the calendar month, for the previous calendar month and shall be made available for review upon request by the AQD staff. In the response to this letter, please submit data to substantiate facility emissions calculations required by PTI number 114-13A for the period of January 2023 through October 2024.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by December 4, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Sheridan Publishing Grand Rapids, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
