VIOLATION NOTICE

On December 15, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Packaging Personified, Inc. located at 122 South Aspen Street, Sparta, Michigan. The purpose of this inspection was to determine Packaging Personified, Inc.'s compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 401-96E.

During the inspection, staff observed the following:

FGFLEXOPRINT	PTI No. 401-96E, Special Condition (SC) V.3	Failure to complete required capture efficiency testing.
FGFLEXOPRINT	PTI No. 401-96E, SC VI.5.c	Failure to maintain usage records for each ink/solvent used.
FGFLEXOPRINT	PTI No. 401-96E, SC VI.5.d	Failure to maintain reclaim/disposal records for each ink/solvent used.

During this inspection, Packaging Personified, Inc. was unable to provide the following records:

- Capture efficiency test results for the non-fugitive enclosure
- Usage rates for each ink/solvent utilized
- Reclaim/disposal rates for each ink/solvent utilized



Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by March 10, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Packaging Personified, Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
