VIOLATION NOTICE

On July 8, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) conducted an inspection of Multi Packaging Solutions (MPS) located at 5800 West Grand River, Lansing. The purpose of this inspection was to determine MPS' compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Permit to Install (PTI) number 170-79H.

During the inspection and review of records, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FG-Packaging	SC I.2 VOC emission limit of 2,000 pounds VOC per month	The 2,000 pounds VOC emission limit was exceeded August and October 2014; and January, February and April 2015.

The records provided demonstrate that actual emissions of VOC from the FG-Packaging process equipment were 3,030 pounds in August 2014; 3,459 pounds in October 2014; 2,272 pounds in January 2015; 2,473 pounds in February 2015; and 2,107 pounds in April 2015.

The Emission Limit conditions of Permit to Install number 170-79H limit the emissions of VOC to 2000 pounds/month for this flexible group.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by October 21, 2015. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If MPS believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of MPS.
