Re: Violation Notice (Recordkeeping requirement specified in Special Condition number 21 of PTI number 519-94), Chor Industries (SNR: N5442, Oakland County)

Dear Mr. Pinga,

On March 9, 2015, the Department of Environmental Quality, Air Quality Division, conducted an inspection of our facility. As a result, Chor Industries received a violation for failure to keep records of the amount of Ammonia and Ethylenediamine used per month.

#### Ammonia Usage

Chor Industries failed to keep records of the Ammonia usage because the company uses the same amount of Ammonia each month. To ensure we comply with the recordkeeping requirement, we have done the following:

1. Reviewed the P.O.s and inventory sheets from 2014-2015 to confirm the amount of Ammonia used.
2. Recorded the amount of Ammonia used per month for January -December 2014. Refer to the chart titled "Chor Industries Ammonia Usage included. The chart also shows the amount of Ammonia used during a twelve month rolling period.

To prevent a reoccurrence of the above violation, Chor Industries will record the amount of Ammonia used for each month starting in 2015 (refer to chart titled "Chor Industries Ammonia Usage).

### Ethlenediamine


Chor Industries failed to keep records of the Ethlenediamine usage because the company uses very little of this chemical during the year. To ensure we comply with the recordkeeping requirement, we have done the following:

1. Reviewed the P.O.s and inventory sheets from 2014 and recorded the amount of Ethenediamine used.
2. 2015 - No usage to date.
3. Recorded the amount of Ethlenediamine used per month for January -December 2014. Refer to the chart titled "Chor Industries Ethlenediamine Usage." The chart shows the total amount of Ethlenediamine used during 2014. Future charts will include a twelve month rolling period.

To prevent a reoccurrence of the above violation, Chor Industries will record the amount of Ethlenediamine used for each month starting in 2015 (refer to chart titled "Chor Industries Ethlenediamine Usage included). These charts will include a twelve month rolling period.
