Amerco Real Estate Co. (SRN N5483) with an address of 2240 Telegraph Road, Southfield (as listed in MACES), is scheduled for a compliance inspection for fiscal year 2014. I attempted to conduct a compliance inspection on October 31, 2013. The purpose of the inspection was to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) Administrative Rules.

There are no plant files for this facility, so I don't know what the air emission sources are at this facility. I conducted a Google search prior to the inspection, and I could not find any Amerco Real Estate facility in Southfield, Michigan. I also could not find the address 2240 Telegraph Road, Southfield since everything on Telegraph in Southfield has a 5 digit number. I inspected a facility located at 22400 Telegraph (instead of 2240 Telegraph), Southfield called Alpha 21 Graphics Center and spoke with Mr. Walt Hutchinson. Alpha 21 is a copy center that uses copying machines. They deal with business establishments and individuals as well. Mr. Hutchinson said they have been at this location for more than 10 years. He is not aware that Amerco Real Estate has ever been at this building.

I drove north on Telegraph Road until Bloomfield Hills where the street number changed to 4 digits. I could not locate 2240 Telegraph Road, but located an office building with an address of 2242 Telegraph Road. The building was occupied by a facility called Unique Systems Design Inc.

At this time, I conclude that Amerco Real Estate is no longer operating at its current listed location. This facility will be marked permanently shutdown in MACES.
