I am unclear of the specific issue in terms of completing "required records in a format acceptable to the AQD District Supervisor" and would request clarity on the issue surrounding the records.

As stated, we have created an abatement plan, which will be sent under separate cover, that will remediate these issues going forward. We have not had any further issues relative to those stated above and are confident that our operations team is cognizant of the issues that led to the violations. In addition, we arranged to have our technician come into the facility, which he did on September 10, 2022, and inspect all of our equipment. There were no issues found with any of the machines.

We have always made every attempt to operate within the confines of our permit and with the wellbeing of our team and the public at the forefront. We are moving to a much larger facility this fall and this will further enhance our ability to manage our workflow and make it easier for our team to operate effectively.
