On Tuesday, September 11, 2018, Michigan Department of Environmental Quality-Air Quality Division (MDEQ-AQD) staff, I, Adam Bognar, conducted an unannounced self-initiated inspection of Burtek Enterprises, Inc., located at 50405 Patricia Avenue, Chesterfield, MI. The purpose of this inspection was to determine the facility's compliance status with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) rules; and Permit to Install Nos. 306-08 and 203-05.

Permit to Install No. 306-08 was issued on October 29, 2008 as an opt-out permit for HAPS. Permit to Install No. 203-05 was issued on August 11, 2005 as a general PTI for coating lines.

I arrived at the facility at around 8:30 am. Burtek Enterprises has permanently shut down business. The name "Burtek" is still posted, but the building is shuttered. Based on what I saw through the windows, the facility has been gutted. The business is listed as "Permanently Closed" on Google. I was not able to determine whether the equipment associated with Permit to Install Nos. 306-08 and 203-05 have been removed since I could not enter the facility.

## **Compliance Determination**

I was not able to verify compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451; Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) rules; and Permit to Install and Operate Nos. 306-08 and 203-05.

The facility appears to be permanently closed. An email was sent to MDEQ permit section on September 20, 2018 requesting to void PTI Nos. 306-08 and 203-05.
