## VIOLATION NOTICE

On August 16, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), received a Semi-annual Excess Emissions/Summary Report and Annual Certification for January 1, 2017, through June 30, 2017, from Real Alloy Recycling, Inc. (Facility), pursuant to 40 Code of Federal Regulation (CFR) 63.1516(b). Based on a review of this report, the Facility is in violation of the following:

FGIMCOBLDG-S2 (EUIMREVERBFURN-S2, EUIMROTFURN1-S2 and EUIMROTFURN2-S2	MI-ROP-N5957-2012e, Condition III.1; 40 CFR 63.1510(i)(1)(i)	The Semi-annual Excess Emissions/Summary Report states that the 8-hour lime check was missed on 6-23-17 on the rotary furnace baghouse and the reverbatory furnace baghouse due to lack of personnel. The previous Semi-annual Excess Emissions/Summary Report received on 2-22-17 also reported failure to complete 8- hour lime checks of the listed baghouses on 9-26-16 due to lack of personnel. Each report stated corrective actions would involve additional checks by the production supervisor would be implemented to ensure 8- hour checks are completed as required.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by October 17, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Facility believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
