On August 15, 2014, AQD staff, Erik Gurshaw, conducted a targeted, unannounced inspection of a portable non-metallic mineral crushing plant owned and operated by Tri City Aggregates at Saginaw Asphalt Plant #7980 located at 10222 Sheridan Road in Millington, Michigan. Upon arriving at the location, AQD staff discovered that the gate to the site was padlocked. Therefore, AQD staff called Mr. Mark Hill, Manager for Tri City Aggregates, Inc., to inquire about the operating status of the crusher. Mr. Hill said that the crushing equipment has been disassembled and is still on the grounds of Saginaw Asphalt Plant #79-80. He said that the plant is scheduled to be moved back to Tri City's corporate headquarters in Holly. According to Mr. Hill, the crusher has not and will not be used this construction season and will most likely be sold prior to the 2015 construction season.

As a result of this inspection, it was determined that the Tri City Aggregates' crusher (N6338) which had been operating at 10222 Sheridan Road in Millington has been disassembled and is in the process of being sold. Since the crusher is still owned by Tri City Aggregates as of the date of the inspection, the PTI associated with the crusher (PTI #146-00 for a portable non-metallic mineral crusher) will remain active until Tri City Aggregates notifies the AQD that the crusher has been sold.
