On November 12, 2015, I conducted a level-2 **scheduled** and self-initiated inspection of Du Pont Herbert's Automotive Systems America, Inc. ("Du Pont") and SH North America, LLC, . ("SH NA"), a subsidiary of SH Global of Korea, located at 30529 Andersen Court, Wixom, Michigan 48393-2877. The inspections were conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

SH AM is in the business of supplying molded automotive parts to auto manufacturers and Tier 1, 2 & 3 suppliers:

- 1. Molded trim components
- 2. Instrument panel system
- 3. Compression molded trim
- 4. Door panel systems
- 5. Center console systems
- 6. Complete interior systems, etc.

All manufacturing takes place in Mexico (mostly) and Canada for North American markets (NAFTA). Of course, manufacturing takes place in Korea for local markets. Pontiac facility provides engineering, sales, service, etc. to the customers. The molded parts are supplied to

GM (mostly), VM, Honda, etc. SH AM is trying to sell the building since 90 percent of the building empty. Only about twenty engineers are working at Pontiac.

No manufacturing at this location anymore. No paint spray booth. No parts cleaner.
