RESOLVED COMPLAINTS:		

I (Matt Karl) arrived to conduct an unannounced inspection of Anrod Screen Cylinder Co. (N6671). The facility produces filtration products such as custom strainers, filters and screens fabricated from wire cloth, perforated or expanded metal and synthetic fabrics. Their customers consist of a wide variety of equipment manufacturers, primarily those concerned with irrigation and aerospace projects, with minimal automotive interests as well. The facility employs approximately 20 staff. The operations process includes small parts soldering and induction welling, as well as shearing, rolling and molding metals and synthetic fabrics.

Upon arrival at the facility, I met with Charmain Bauerschmidt, Q.A. Manager. During our initial meeting I obtained the floor plan (attached) and received a walk through of the facility. During our walkthrough I noted the presence of the parts wash room and degreasing room, and requested the information about the make and model of the degreaser.

On 1/25/18 Charmain Bauerschmidt provided me with the requested information about the degreaser unit via email. Based on this information, I was able to determine that the degreaser unit was subject to 40 CFR Part 63, Subpart T the National Emission Standards for Halogenated Solvent Cleaning. Having the degreaser unit installed and operated without a permit was a violation of the Rules 201 Permit to Install and 651 Standards for Degreaser. A violation notice followed on 1/31/18.

Greg Biddinger, President of Anrod Screen Cylinder Co. responded to the violation letter on 2/12/18. On 2/20/18 G. Biddinger requested a permit engineer be assigned to their facility to address their permit to install application which they began working on to address the violation notice.

On 3/1/18 G. Biddinger and I set a date of 4/2/18 to have a permit to install application in for review.


