On August 4, 2014, I, Rebecca Loftus, from the Department of Environmental Quality's (DEQ), Air Quality Division (AQD), conducted a self-initiated inspection of Glassman Automotive Group, SRN: N6677, located at 28000 Telegraph Road, in Southfield, Michigan. The inspection was prompted as part of an effort to clean up AQD files. The purpose of this inspection was to determine the facility's compliance with the Federal Clean Air Act, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act of 1994, PA 451, as amended, and Michigan's Air Pollution Control Rules.

I arrived on-site and met with Mr. Michael Welch, Service Director.

## File Review

Previously this facility was Glassman Oldsmobile. The file list two addresses 25001 Telegraph and 28000 Telegraph. A BP Gas station is located at 25001 and the Dealership/Auto Repair is located at 28000. The AQD database has the address listed incorrectly as 2800 Telegraph. A request will be made to have this corrected.

In 2000, Glassman Oldsmobile submitted information stating they do not use halogenated solvents and Chris Ethridge verify this during an inspection of the facility.

## Inspection Observations

Mr. Welch escorted me through the service garage and provided me the MSDS for the "Brake Cleaner" (see attached). Mr. Welch said they order approximately two 55 gallon drums of the multi-purpose solvent each month and the used solvent is stored in sealed containers, until it is picked up along with other waste materials (used oil, coolants, etc) by Vesco Oil Corporation.

Based on the MSDS, Glassman Automotive Group does not use Halogenated Solvents at this location, therefore, the facility does not appear to be subject to 40 CFR Part 63 Subpart T, The National Emission Standards for Halogenated Solvent Cleaning.

At this time, no back-up generators or paint booths are located at this facility

#### Additional Information

Mr. Welch is also the manager for the painting operations at Glassman's paint shop located at 22250 Telegraph Road. The paint shop address does not appear to be in the AQD database. Mr. Welch provided the paint usage for the paint shop. From January 1, 2014 through January 30, 2014, the paint shop used 104 gallons (see attached records). Based on the information provided, the painting operations appear to be exempt from obtaining a Permit to Install pursuant to Rule 287(c).

#### Conclusions

Based on information gathered, at this time, the facility located at 28000 Telegraph Road, appears to be in compliance with Michigan's Air Pollution Control Rules and the Federal Clean Air Act.
