## REGULATORY AUTHORITY

Under the Authority of Section 5526 of Part 55 of NREPA, the Department of Environment, Great Lakes, and Energy may upon the presentation of their card, and stating the authority and purpose of the investigation, enter and inspect any property at reasonable times for the purpose of investigating either an actual or suspected source of air pollution or ascertaining compliance or noncompliance with NREPA, Rules promulgated thereunder, and the federal Clean Air Act.

## FACILITY DESCRIPTION

A. Lindberg & Sons, Inc. (ALS) provides civil construction services including site development, road construction, utility infrastructure projects, and rock crushing, screening and washing. ALS is the largest aggregate and stone producer in the Upper Peninsula (UP). The company is headquartered in Ishpeming, Marquette County, and has multiple aggregate pits and portable crushing facilities throughout the UP. Aggregate is used for concrete and asphalt mixes, road gravel and subbase, foundation stone, erosion control, and architectural/landscaping purposes.

### PTI# 119-99

This portable facility is permitted as a portable crushing facility; it is a screening plant. No crusher units were ever associated with this PTI. The following equipment is associated with PTI# 119-99:

The last relocation notice that was submitted for this portable facility was submitted 7/15/2011 to operate at the ALS County Road 480 Pit. ALS Crusher Supervisor Jon Pacl stated the facility has been on standby since late 2011 at the County Road 480 Pit. There are no plans for the portable facility to operated in 2021. MAER submittals from 2015 to 2020 report no emissions due to not operating.

## SUMMARY

The facility is a screening plant on standby and has not operated since 2011.

**R 336.1285 Permit to install exemptions; miscellaneous**

Since the issuance of PIT# 119-99 equipment for the mining, loading, unloading, and screening of uncrushed sand, gravel, soil, and other inorganic-like materials is now exempt from permitting under Rule 285(2)(t). This facility is eligible for the PTI to be voided at the request of the company.
