**VIOLATION NOTICE**

On March 26, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) met with you at the site of Enviro Tech Coatings located at 1900 Austin Street, Midland, Michigan. The purpose of this visit was to determine your facility's compliance with the requirements of the federal Clean Air Act, 1994 PA 451, as amended (Act 451). We also discussed your Michigan Air Emissions Report submittal (MAERs) and air use permitting – both current and future. The facility is currently covered by air use permit to install 52-00B.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
New spray booth at north end of blast barn	R336.1201 (Rule 201)	Facility already installed a spray coating operation without an air use permit.

It should be noted the facility already had an existing air use permit but still a new booth was installed prior to obtaining a permit. Permitting options were discussed at length. Links to forms and instructions were provided on March 27, 2015. On April 6, 2015, Mr. Popp inquired via e-mail about re-doing the air permit and if that would occur in the near future. Mr. Popp was reminded links and forms to instructions were previously provided and that the process begins when the facility starts filling out the application. As of June 3, 2015 a permit application had not been received. Be advised that Rule 201 requires that a permit be obtained prior to installation, construction, operation, reconstruction, relocation, or alteration of any process or process equipment which may be a source of an air contaminant.


Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 13, 2015 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are

proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Enviro Tech Coatings believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection. If you have any questions regarding the violation or the actions necessary to bring this facility into compliance, please contact me at the number listed below.
