LOCATION

The animal hospital is located in rural Pickford at the intersection of 3 Mile Road and East Taylor Road; East Taylor Road dead ends just west of the hospital. The area is rural; however there is a single-family residence located approximately ¼ mile to the south of the hospital.

SOURCE DESCRIPTION

This is a rural veterinary clinic and hospital.

INSPECTION

On 3/16/2015 I conducted an unscheduled visit of the Pickford Animal Hospital. PPE worn during this inspection included steel-toed boots, safety vest, safety glasses and hardhat. The hospital is located at Dr. C.A. Grover's residence. There was no answer at the door at the time of my inspection. A phone call to the hospital at a later date confirmed they were still operating the Pro-Line Model 430 refractory-lined incinerator with an afterburner that was permitted in 2002 under PTI# 75-02. The incinerator is operated using fuel oil.

 - The incinerator continues to only burn pathological waste

 - Staff was not able to confirm that minimum operational temperature is being achieved because there was no
 one at the facility at the time of inspection.

 - Staff was not able to confirm that minimum operational temperature is being achieved because there was no
 one at the facility at the time of inspection.
- V. RECORDKEEPING/REPORTING Daily records of description and weight of waste being combusted in EU-Crematory; kept on file for minimum of 5 years.
 - Staff was not able to confirm that records are complete because there was no one at the facility at the time of inspection.

SUMMARY

No violations of PTI# 75-02 were observed at the time of this inspection, however staff did not make contact with permittee at the time of inspection and was not able to review records or see the crematory in operation. Staff recommends a scheduled inspection in the future due to the sporadic use of EU-Crematory and hours of operation of Pickford Animal Hospital.




Image 1(PVH1): Former incinerator bldg




Image 2(PVH2): Retired incinerator




Image 3(PVH3): Retired incinerator
