VIOLATION NOTICE

On April 7, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) staff conducted an inspection of KIRCHHOFF Van-Robb located at 16325 Felton Road, Lansing. The purpose of this inspection was to determine compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, Act 451 of 1994, as amended; and the Air Pollution Control Rules.

During this inspection, it was noted that a number of welding cells have adhesive glue application installed and operating at this facility. The adhesive glue contains volatile organic compounds (VOC) which is a regulated pollutant. At the time of inspection, nine of the adhesive glue application areas appeared to meet an exemption rule from permitting. One of the adhesive glue application areas did not appear to meet an exemption rule. There have been numerous discussions regarding options for the unpermitted adhesive glue application area. The last discussion occurred on August 11, 2016. At this point, AQD staff has determined that this is a violation of R 336.1201 (Rule 201) – Permits to Install (PTI).

A program for compliance may include a completed PTI application for the adhesive application process equipment. An application form is available by request, or at the following website:

Be advised that Rule 201 requires that a permit be obtained prior to installation, construction, operation, reconstruction, relocation, or alteration of any process or process equipment which may be a source of an air contaminant.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by October 19, 2016. The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If you believe the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection.
