(ECT), on behalf of Ward Lake Energy (WLE), compiled the following response to the Michigan Department of Environmental Quality-Air Quality Division (MDEQ-AQD) Violation Notice dated March 19, 2018 for the Vienna 6/7 CPF, Permit to Install (PTI) 226-02A, SRN N7190.

The following violations were cited:

The following information was requested by MDEQ-AQD in the Violation Letter:

- Dates the violation occurred: The PTI application indicated a Caterpillar G3408TA 400 hp engine would be installed whereas a Caterpillar G3408TA 405 hp engine was installed.
- Explanation of the causes and duration of the violations: A different engine than what was permitted was installed that resulted in actual emissions exceeding emission limits.
- Whether the violations are ongoing: The violation is ongoing but, as discussed below, is being addressed via PTI Application 226-02B dated February 8, 2018.
