VIOLATION NOTICE

On May 22, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Atmosphere Heat Treating Inc. located at 30760 Century Drive, Wixom, Michigan. The purpose of this inspection was to determine Atmosphere Heat Treating's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number 174-04A.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
FGHEATTREAT	PTI No.174-04A Special Condition I.1	The calculated 12-month rolling time period PM emissions from 2018-2023 exceeded the permit limit of 3.0 tpy for multiple months.

The submitted records showed that the calculated 12-month rolling time period PM emissions for the periods ending December of 2019 (3.6 tpy), January through June of 2020 (3.6 tpy each month), February through May of 2023 (4.5 tpy each month), and July through December of 2023 (4.5 tpy each month), exceeded the permit limit of 3.0 tpy. These calculated PM emission rates were in violation of PTI No. 174-04A Special Condition I.1.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by July 15, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Atmosphere Heat Treating Inc. believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
