## **VIOLATION NOTICE**

On Thursday, July 7, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), observed a stack test conducted at Eteron Incorporated located at 23944 Freeway Park Drive, Farmington Hills, Michigan. The purpose of this observation was to witness the stack testing conducted to determine Eteron Incorporated's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; the conditions of Permit to Install (PTI) number 90-14A and Consent Order AQD number AQD No. 13-2015.

AQD alleges the following violation after the stack test:

This process is also subject to the federal National Emission Standards for Hazardous Air Pollutants (NESHAP) for Surface Coating of Plastic Parts and Products. These standards are found in 40 CFR Part 63, Subpart PPPP.

The cited Special Condition number V.2 of PTI number 90-14A is also enforceable as paragraph 9A of Consent Order, AQD number 13-2015.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by October 19, 2016 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether

the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Eteron Incorporated believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violation cited above and for the cooperation that was extended to me during my inspection of July 7, 2016.
